Terms & Conditions

Welcome to "7amleh" website, at www.7amleh.org (the "**Website**"). The Website is operated by 7amleh - The Arab Center for the Advancement of Social Media (R.A)("**7amleh**", "**Us**" or "**We**"). In these Terms and Conditions (the "**Terms**"), "You" refers both to you as an individual and to the entity You represent (as applicable).

These Terms apply to the Website and all other 7amleh's network of websites and affiliated websites, all mobile and web applications published by 7amleh and/or its partners as separate initiatives, and all other interactive features, services and communications provided by 7amleh, that are operated by 7amleh, including, without limitation, the Digital Security Platform, as defined in Section 1 (together, the "Additional Sites", and together with the Website, the "7amleh Websites").

Certain Additional Sites may have their own terms and condition (or similar agreements) which will be displayed prominently on such Additional Site. If no such terms and conditions are available on an Additional Sites, these Terms will apply on your use of such Additional Sites. If an Additional Site includes its own terms and conditions, then by using such Additional Site, You agree to be bound by the terms and conditions specific to that Additional Site in addition to these Terms.

7amleh is a non-profit organization that advocates for Palestinian digital rights. 7amleh studies and researches issues related to Palestinian digital rights, provides digital rights, digital activism and digital security capacity building opportunities to Palestinian activists and civil society, and manages local and international advocacy campaigns.

The Website provides information, tools and resources to help Palestinian individuals and organizations increase their awareness relating to digital rights and improve their digital activism. The Website may include features necessary for digital rights assessments and information about digital rights laws and policies, and recommendations for protecting digital rights of Palestinians. The Website may also include information about digital rights violations and advocacy efforts as well as educational materials about digital rights and digital security.

2. The Additional Sites

The Website may include links to the Additional Sites. These website and applications are either affiliated with or operated by 7amleh and/or its partners as separate initiatives which focus on specific cause or campaign, and include, among others, 7amleh's Digital Security Site 'Aman Rakami' المان رقمي (the "Digital Security Site").

The Digital Security Site includes tools and resources for promoting awareness and familiarity with assessing and improving digital security and will combine important information made available to civil society organizations, journalists and HRDs tools designated to enhance successful digital advocacy.

The Digital Security Site will enable You among others, to view certain content and material, and download and or view recorded sessions and trainings via 7amleh's online services. The Digital Security Site may also include information about digital security threats, vulnerabilities or risks.

Without derogating from any provision herein, 7amleh does not guarantee the effectiveness or reliability of any tools available on the Digital Security Site and is therefore not responsible for any damage or loss resulting from their use. 7amleh is also not responsible for any damage or loss resulting from your reliance on any information provided on the Digital Security Site.

7amleh shall have the right to remove any Additional Site or links thereto from the Website at its discretion.

3. <u>Content and Materials on the Websites</u>:
